**Planning Application For Replacement Sash Windows to 2<sup>nd</sup> and 3<sup>rd</sup> Floors with UPVc Sash Windows  
At 14 Nottingham Road, Ilkeston, Derbyshire DE7 5RE.**

### **Design and Access Statement.**

The Planning Application is to replace three windows on the frontal aspect of the property.

#### **Assessment**

**Physical** fenestrations. The building will remain the same, the replacement windows being made to fit the existing

#### **Planning Policy**

**LP1** Sustainable Development - replacing existing sash windows with double glazed upvc sash windows will reduce maintenance, reduce heat loss from building and be in keeping with other properties.

**DC10** Replacing the windows will enhance the building and in no way will it harm the appearance of the surrounding area. The majority of the surrounding commercial properties having upvc units.

#### **Design**

**Use** The use of building will remain the same - Optometric Practice.

**Amount** Three replacement windows having same appearance as original but constructed in upvc for ease of maintenance

**Layout** There will be no change from present.

**Scale** The windows are to fit existing fenestrations so scale will be same - section of material used may differ slightly from original.

**Appearance** The building will appear the same as now and over the past 114 years, with the exception of the three made to measure double glazed upvc windows, having design as near as possible to original.
