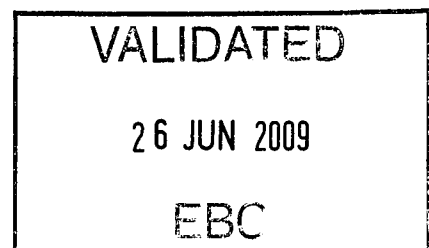

Site and surroundings

The site is of an area of .06 ha and lies on the South side of Poplar Avenue Sandiacre, a public service cul du sac road entirely of residential properties, none of which are of particular architectural merit that would influence the style or design of the proposal.

The site is formed from part of the original garden to 124 Stanton Road Sandiacre immediately to the South of the site. The site would be accessed from Poplar Avenue by way of a new vehicular driveway formed through the existing brick retaining wall on the highway boundary.

Application details

The proposed two Bedroom Bungalow would provide a detached dwelling with parking and a future garage facility. It would be a single storey brick and tile building with a foot print of 64 sq m. and would be well related to its surroundings.

Care has been taken with the layout and design, avoiding overlooking adjoining properties, particularly on the West Elevation.

Current building regulations requiring an energy efficient building with low carbon properties, dictating the quality of the building to be constructed.

The accommodation incorporates a Lounge, Study Kitchen, Entrance Hall, Bathroom and two Bedrooms

There has been no change in circumstances since the last outline consent under ERE/0704/0077

Planning Policy

It is considered the proposal accords with the Development Control Saved Policies adopted 28th July 2008 and in particular PPS1- Sustainable Development & PPS3 – Housing.

PPS1 - Developing suitable available land in line with economic, social and environmental objectives by improving people's quality of life.

PPS3 - Achieving high quality housing –Effective use of land.

Access

The site would be accessed from Poplar Avenue by way of a new vehicular driveway formed through the existing brick retaining wall on the highway boundary. The new access would be constructed to the requirements of the Planning Authority. The access and drive would be surfaced with self draining drive setts.

Poplar Avenue would be unaffected by the development.
