In consultation with Mr Grant of Grant Bros. Tree Surgeons. He estimates that the silver birches will be pruned 20% and reduced in height not more than one metre. The lime tree could be reduced by one metre. There are one copper beech tree about which I would appreciate some advice, no treatment of this tree is envisaged at present, but that situation could alter following consultation.

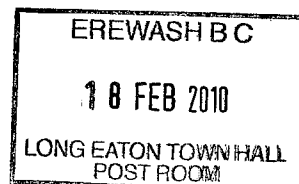

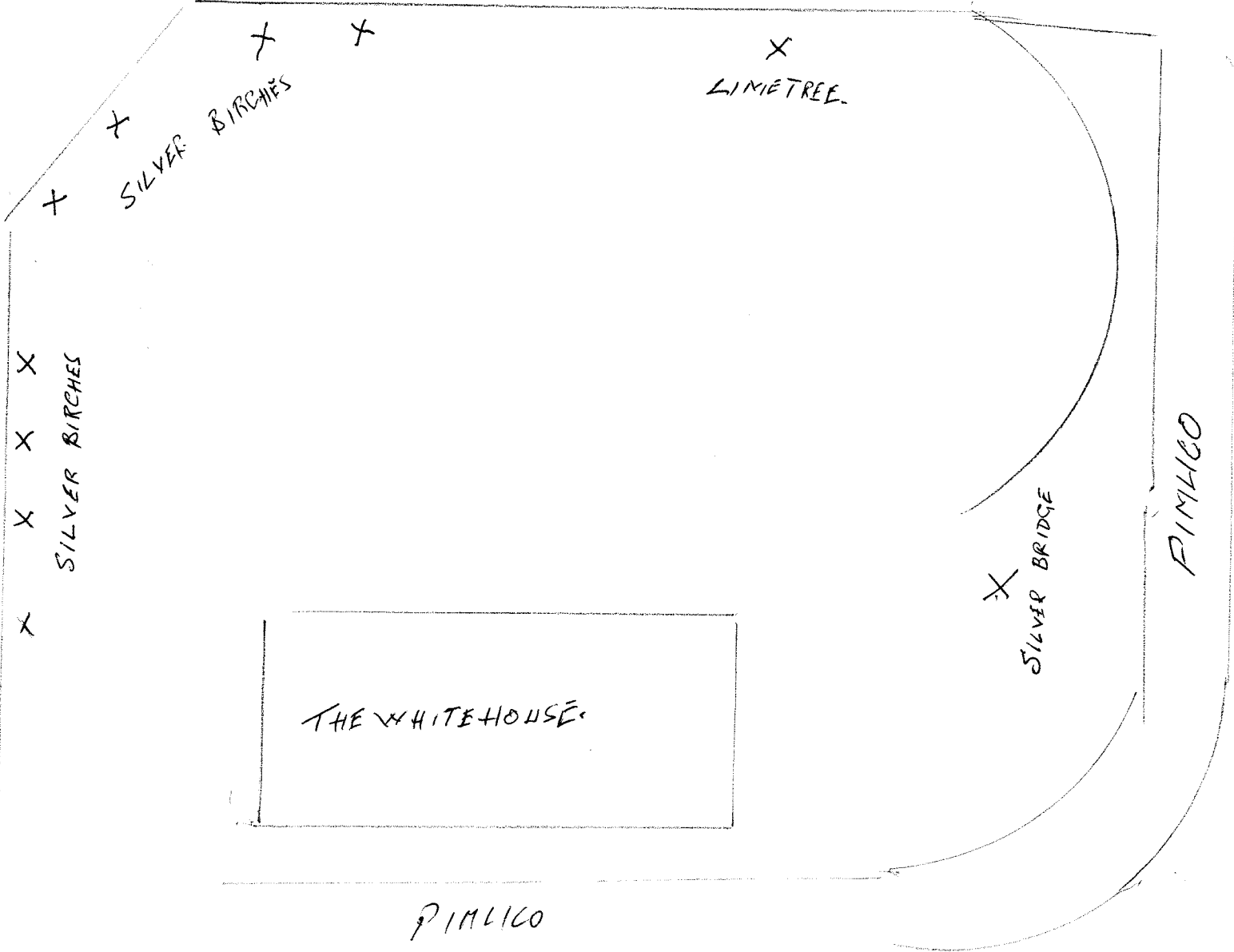
